



# 100\$ Bonus Campaign 2021

FINVEO

1. These Terms and Conditions (hereinafter: The Rules) apply to the **100\$ Bonus Campaign** (hereinafter: **The Campaign**). By participating in the Campaign, you agree to be bound by these Rules.
2. This Campaign is offered by Finveo which is licensed by The Capital Market Authority of Montenegro on 31.07.2020, number of license: 03/2-2/11-20.
3. To qualify for the Campaign, the applicant must complete a live registration form, submit necessary documents, open live trading account and deposit certain amount of funds. If everything submitted in accordance with Law and internal regulations of Finveo, the applicant will become the Client (hereinafter **The Client**).
4. Client who deposits amount for the first time, from 100\$ to 400\$ is entitled to receive the 100\$ bonus of the Campaign (hereinafter **The Bonus**). Received Bonus can't be withdrawn, it can only be used for trading.
5. There is no limited number of Clients who can receive the Bonus.
6. The Client must be:
  - a) an individual who is 18 years or older
  - b) a new client to FINVEO, not having previously held an account with Finveo.
7. Opened account by applicant is subject to Finveo's standard onboarding process, and all applicants may not be successful in their application for an account and become Clients.
8. Finveo reserves the right to ask the Client for all necessary Know Your Customer related documentation to comply with Finveo's Know Your Customer procedures and protect against fraud, before the Client is eligible to participate in this campaign. Any restrictions that apply to an account will be detailed in the email to the account holder upon account activation.
9. The Campaign is not open to employees of Finveo.
10. The Campaign and any obligations of Finveo in accordance with it will be revoked or withdrawn from participants who abuse the spirit or intention of it.
11. Finveo reserves the right to remove the Bonus from Client's account, if a Client is inactive for 2 months and doesn't trade 2 lots.



12. Finveo is the sole arbiter of the Campaign, these Rules and any other issues arising under this Campaign. Exceptions to these Rules are at the sole discretion of Finveo management right to alter, amend or terminate the Campaign or any aspect of it (including the Rules) at any time and without prior notice is reserved.

13. Finveo will not be held liable for any losses incurred by Client as a result of Client's trading or in relation to this Campaign.
