

## QUESTIONNAIRE OF CLASSIFICATION OF THE CLIENT AS A SMALL INVESTOR

In accordance with the Law on Capital Market ("Official Gazette of Montenegro", No. 001/18) (hereinafter: the Law), we classify you as a Small Investor.

In accordance with that, we will execute your orders accordingly with applicable laws and regulations.

Upon your special written request which you can send to the e-mail address: [compliance@finveo.mn](mailto:compliance@finveo.mn), and in accordance with the Law, we will provide you with treatment with a lower level of protection that we provide to professional investors, for the overall services, or for each transaction separately.

Small investors can be classified as professional investors if they meet at least two of the following criteria:

1. If the Client has realized at least 10 transactions in each quarter in the last year,
2. If the size of the Client's portfolio of financial Instruments exceeds EUR 500,000.00,
3. If the Client is employed in the financial sector or has worked in the financial sector for at least one year in jobs that require knowledge of the Capital Market.

Classification of the Client as a professional investor implies different regulations when executing orders under the most favourable conditions.

For professional clients, the decisive factor in the execution of the order is the relative importance of the criteria according to which the order will be executed (not only the price and transaction fees as for small Investors, but also the speed, probability of order execution and transaction settlement).

Your classification as the Small Investor provides you with the highest level of protection under the Law.
